## 4. FIRST AID MEASURES

For advice, contact a Poisons Information Centre (e.g. phone Australia 131 126; New Zealand 0800 764 766) or a doctor.

### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

### Skin Contact:

Wipe excess material from skin with a clean rag or paper towel (do NOT use solvent to clean skin). If skin contact occurs, remove contaminated clothing and wash skin with running water. If irritation occurs seek medical advice.

### Eye Contact:

If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

**Ingestion:**

Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Seek medical advice.

**Medical attention and special treatment:**

Treat symptomatically.

## 5. FIRE FIGHTING MEASURES

**Hazards from combustion products:**

Flammable paste. On burning will emit toxic fumes.

**Precautions for fire fighters and special protective equipment:**

Heating can cause expansion or decomposition of the material, which can lead to the containers exploding. If safe to do so, remove containers from the path of fire. Keep containers cool with water spray. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

**Suitable Extinguishing Media:**

Alcohol resistant foam is the preferred firefighting medium but, if it is not available, normal protein foam can be used.

## 6. ACCIDENTAL RELEASE MEASURES

**Emergency procedures:**

If contamination of sewers or waterways has occurred advise local emergency services.

**Methods and materials for containment and clean up:**

**SMALL SPILLS:** Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.

**LARGE SPILLS:** Shut off all possible sources of ignition. Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

## 7. HANDLING AND STORAGE

**Conditions for safe storage:**

Store in cool place and out of direct sunlight. Store in a well ventilated area away from foodstuffs, oxidising agents and sources of heat or ignition. Keep containers closed when not in use - check regularly for leaks.

**Precautions for safe handling:**

Avoid skin and eye contact and breathing in vapour. May form flammable vapour mixtures with air. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke.

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. ## Engineering controls:

<b>Eye contact:</b>	May be an eye irritant.
<b>Skin contact:</b>	Contact with skin may result in irritation. Will have a degreasing action on the skin. Repeated or prolonged skin contact may lead to irritant contact dermatitis.
<b>Inhalation:</b>	Material may be irritant to the mucous membranes of the respiratory tract (airways). Breathing in vapour can result in headaches, dizziness, drowsiness, and possible nausea. Breathing in high concentrations can produce central nervous system depression, which can lead to loss of co-ordination, impaired judgement and if exposure is prolonged, unconsciousness.
